# Bids for Scott air packs for the Fire Department (Bid No. 6-12-13):

Greg Brown recommended that Council approve the request to purchase Scott air packs in the amount of \$49,577 with a FEMA Grant match of \$198,308 and allow the Fire Department to proceed with the purchase.

# Request to abandon an easement within the Drury Inn development:

Presented by - Pat Collins, City Engineer - In October, 2002, Impac Hotels granted a permanent utility easement to the City for the purpose of using and maintaining a water main across their property. Drury Development

Corporation recently redeveloped the property and abandoned a portion of the water main and installed new water mains. Drury has asked that the City formally abandon that portion of the City's easement that is no longer needed. Pat Collins recommended that Council approve the request to abandon an easement within the Drury Inn development.

# Request to appeal the decision on a Certificate of Appropriateness by the Historic Preservation Commission for relocation of 11 houses:

Presented by Bill Nijem, Attorney, 209 East Alden Avenue, representing McAllister Development Company - They are appealing a decision made in December, 2012 by the Historic Preservation Commission (HPC). As a result of the appeal, they have had some ongoing discussions with City Staff and they are agreeable to tabling this request and go back before the HPC at their February 4, 2013 Meeting. Mr. Nijem asked Council's consideration in tabling the request; however, if things do not work out with the HPC, they would like to come back before Council at the February 7<sup>th</sup> City Council Meeting to address the appeal and to get a yes or no answer from Council on the request without conditions.

Motion to Postpone - Councilwoman White - Postpone until the appeal until the February 7, 2013 Council Meeting with the condition that the HPC hear the case and make its final decision on this matter at its February 4, 2013 Meeting.
