3. Public Hearings

- a) Consideration of an Ordinance to amend the City of Valdosta's Land Development Regulations (LDR) as it pertains to Chapter 106 - Definitions, Chapter 210 - Overlay Districts, and Chapter 230 - Sign Regulations (File No. VA-2016-09). The Greater Lowndes Planning Commission reviewed this request at their May Regular Meeting and recommended approval (5-1 vote). This request was tabled at the June 9, 2016 Regular Council Meeting until the June 23, 2016 Regular Council Meeting. - **Approved (5-2 Vote) with Councilman Ben Norton and Councilwoman Vivian Miller-Cody voting in opposition.**
