The property is located at 200 East College Street. The Planning Commission reviewed this at their October 27, 2025 Regular Meeting and recommended approval subject to four conditions (9-0 Vote).
- b) Consideration of an Ordinance to rezone a total of 75.44 acres from Single-Family Residential (R-6) and Environmental Resource (E-R) to Heavy Industrial (M-2) as requested by Smyrna Ready Mix Concrete LLC (File No. VA-2025-12). The property is located at the western end of East Savannah Road. The Planning Commission reviewed this at their October 27, 2025 Regular Meeting and recommended approval (9-0 Vote).
- c) Consideration of an Ordinance to rezone a total of 49.92 acres from Planned Residential Development (PRD) and Highway-Commercial (C-H) to a combination of Multi-Family Residential (R-M) and Single-Family Residential (R-10) as requested by John Owens (File No. VA-2025-14). The property is located at the southwest corner of the intersection of Inner Perimeter and Jaycee Shack Roads. The Planning Commission reviewed this at their October 27, 2025 Regular Meeting and recommended approval (9-0 Vote).
- d) Consideration of an Ordinance to rezone 1.80 acres from Single-Family Residential (R-15) to Single-Family Residential (R-6) as requested by Stoker Development LLC (File No. VA-2025-15). The property is located at 310 Eager Road. The Planning Commission reviewed this at their October 27, 2025 Regular Meeting and recommended denial (6-3 Vote).
