RE-INSPECTION FEES: There shall be a re-inspection fee of **\$25.00** for all building, electrical, plumbing and mechanical re-inspections. Fee shall not be charged until the third re-inspection.

Commercial PLAN-REVIEW FEES: When the construction exceeds \$1,000.00 or a plan is required to be submitted a plan review fee shall be paid to the City of Valdosta at the time of submittal. Fee shall be equal to one-fourth of the building permit fee and is in addition to the building permit fee. **\$50.00 min charge for plan review**

AUTOMATIC SPRINKLER SYSTEMS: For the inspection and permitting of automatic sprinkler systems, the permit fee schedule shall be as follows; **\$50.00 min charge all permits**
