

City of Valdosta Honored By Easter Seals

The Valdosta Board of Directors for Easter Seals Southern Georgia hosted a staff appreciation and community awards event on February 11th, at the Holiday Inn Conference Center. Over 50 people were on hand to applaud the efforts of staff, volunteers, donors and supporters.

The City of Valdosta, was recognized for its leadership role in supporting individuals with disabilities, particularly those who have transitioned from the developmental disabilities program at Rose Haven (Southwestern State Hospital in Thomasville).

Easter Seals Southern Georgia presented an award to Planning and Zoning Administrator Matt Martin for educating officials about the federal Fair Housing Act and its implications on local government. Martin attended the recent Georgia

Municipal Association Mayor's Day Conference, where he served on the Municipal Institute Training panel that presented best practices in local government policies and procedures around fair housing. This session helped city officials learn how to address neighborhood concerns and understand their obligations under the law in order to limit potential liability and exposure to claims of non-compliance under the federal Fair Housing Act. Martin's session also addressed planning for inclusion of group homes and multi-generational living within a community.

Valdosta's City Manager Larry Hanson was also recognized for his appearance in a soon-to-be released video produced by the Department of Behavioral Health and Developmental Disabilities that speaks to community inclusion of individuals transitioning from state hospitals. The City of Valdosta was recognized overall for its spirit of hospitality and engagement not only in its support of Easter Seals programs but all programs impacting the quality of life for its citizens with special needs.

New Tool Available To Aid In Flood Evacuation Decisions

The U.S. Geological Survey announced recently a flood tracking chart, available online, which allows users to compare current river levels to historic flood levels. The [USGS Flood Tracking Chart](http://waterdata.usgs.gov/usa/nwis/rt) contains data from the five most recent historic floods at various locations along the Withlacoochee and Little River Basins, which the public can use to compare to current river levels to determine whether a flood threat exists for their location. This chart was developed in response to public inquiries as a result of major flood events that occurred in Valdosta and Lowndes County in 2009, 2011, and 2013. Many property owners wanted to know how forecasted conditions compared to recent floods in order to know whether their property would be affected. The USGS Flood Tracking Chart is able to correlate that information.

Developed out of meetings with federal, state, and local officials to find solutions that address recent

flooding in the Withlacoochee and Little River Basins, this chart covers the headwaters of the Little River near Tifton and follows the basin downstream to Valdosta where it joins the Withlacoochee River and continues southward to Lee, Florida. The reverse side of the chart features useful tips to prepare for and survive the next flood, as well as a list of emergency contact information.



By promoting early awareness and education, it is hoped that the Flood Tracking Chart will be a valuable resource in mitigating damages caused by flooding. Referring to this new flood tracking tool, Emily Davenport, Valdosta's Stormwater Manager, stated, "Past events are kept in citizens memories, and by comparing the current forecast to past flooding, it will hopefully encourage people to take appropriate actions based on the severity of the event."

Spring Stormwater Tips



Stormwater pollution can impact our waterways all year-round. To help keep Valdosta's stormwater system operating properly and reduce pollutants from entering our waterways, here are a few tips to remember as we enter spring:

- * To prevent flooding, do not leave yard waste in the street or sweep into a storm drain.
- * Use pesticides and fertilizers sparingly and well in advance of a storm event to minimize algae growth.
- * Collect rainwater from your roof in a rain barrel for use on your lawn during drier times.
- * Repair automobile leaks and dispose of used auto fluids and batteries at designated drop-off or recycling locations.
- * Wash your car on your yard, so that the water infiltrates into the ground.
- * When walking your pet, remember to pick up and dispose of pet waste properly.

Submit Your Preservation Awards Nomination Today!

Nominations are being accepted for the 6th Annual Valdosta Preservation Awards. This program recognizes historic property owners who go "above and beyond" in their efforts to restore their historic buildings. Award winners are presented with a framed certificate signed by the Mayor and an award banner that can be displayed on their historic building.

Projects may be nominated for three categories: Outstanding Achievement (for major restoration projects) Distinguished Merit (for minor restoration projects), and Excellence in Compatible New Construction (for new buildings that are compatible with the historic district's character). There is also a Stewardship Award for owners of historic buildings who have consistently cared for and maintained their building. Final-

ly, the Harold Bennett Lifetime Achievement Award recognizes an amazing individual for their contributions to historic preservation in Valdosta.

The 2014 Valdosta Preservation Awards will be presented on May 22nd at the Valdosta City Council meeting.

New Overlay Expands Land Uses In Historic District


In early February, the new Historical Overlay District was adopted by the Valdosta City Council. This overlay is an amendment to the City of Valdosta's Land Development Regulations (LDR), and allows more flexibility of land uses and site development standards within Valdosta's local Historic District that might not otherwise be permitted by the City's conventional zoning districts.

The creation of the Historical Overlay District resulted out of discussions between staff and the Historic Preservation Commission (HPC) over the past several months. The HPC, Greater Lowndes Planning Commission, and City Council were unanimously in favor of this new Overlay District, because it encourages the protection and reuse of historic buildings and allows for traditional uses and development standards, which enhance the character of the City's historic neighborhoods.

Imagine a large historic home that might make a fine Bed & Breakfast or a civic club building. However, due to its residential zoning, it is not eligible to be rezoned to commercial to allow such a use; indeed, such a rezoning might be illogical given the surrounding development patterns. The Historical Overlay District allows the possibility of such change in use to be considered by City Council through the Conditional Use Permit process on a case-by-case basis. The general idea is that such alternative uses may be more acceptable and compatible in a historic neighborhood setting, rather than a modern residential subdivision.

Another example of this Overlay's purpose is the building or expansion of a house on an existing lot in the Historic District. These lots are often small or narrow. Historic buildings built on these lots pre-date the City's development and setback regulations. The Historical Overlay District allows the use of historic setbacks, which are usually closer to the street and other property lines, without the property owner having to go through the Zoning Board of Appeals Variance process—saving the owner time and money, and resulting in a traditional building appearance along the street.

The Historical Overlay District complements the existing Historic Preservation Ordinance and Design Guidelines within the LDR. For more information about the Historical Overlay District, contact Emily Foster at efoster@valdostacity.com or 229-259-3563.

Regional Transportation Projects Update

The Metropolitan Planning Organization housed at the Southern Georgia Regional Commission recently announced status updates for some our region's transportation projects. These projects are coordinated by the Georgia Department of Transportation. Projects affecting Valdosta are listed below, and are either ongoing or planned to begin in the near future.

GA 133 - Widening, 4 Lanes - Valdosta to Albany - \$326+ Million

The Billy Langdale Parkway of SR 133 is a major north-south corridor in South Georgia and provides a vital connection between Valdosta and Albany. SR 133 is identified for widening due to its inclusion in the Governor's Road Improvement Program to address the importance of stimulating economic growth via an improved transportation network.

I-75 Phase II - Bridges and Interchange Improvements - \$172+ Million

Completed in 2008, Phase I consisted of widening I-75 to 6 lanes. I-75 Phase II will replace bridges and ramps at several interchange locations to improve safety and traffic operations on I-75 throughout Lowndes County. Bridges will be widened to accommodate 8 lanes on I-75 in the future, as well as provide travel lanes for increasing traffic growth on adjoining roadways.

Begun in 2011, this project to construct a 4 lane bridge over the Norfolk Southern Railroad and parallel frontage roads is currently under construction. This project is ahead of schedule to be completed in Fall 2014.

Be Smart: Submit a Site Plan at the START!

The City of Valdosta strongly encourages Site Plan submittal BEFORE full plan submittal. This allows staff the opportunity to comment on major components of the development, which can affect all aspects of the site. Items on the Site Plan should include setbacks, parking, buffering, access, detention, and landscaping. Each of these items has a significant impact on the location and layout of a building, which can affect the architectural and building plans. Unfortunately, if items are shown incorrectly on the Site Plan and a full set of plans has already been created based on incorrect information, the result is often wasted time and money.
