#### Signs, Signs, Signs

When starting a new business, or rebranding an existing business, one of the most common items to look at is a sign. Are any changes going to be made to a freestanding sign? Does the business want a banner or a portable? How much will it cost? One of the questions that should be asked is, "Does it need a permit?"

Most sign contractors, and most business owners, know that free-standing signs and wall signs most generally will require a permit. If you'd like a new wall sign, or a bigger/smaller freestanding sign, you are responsible to get the signage permitted.

However, many people assume that because a sign is temporary (i.e. a banner, a portable, or pennant flags), it doesn't need a permit. However, both banners and portables DO need a permit. The cost is minimal, at \$35 for a banner permit or for a portable

permit, and you may display that banner or portable until December 31, 2015. However, portables are NOT permissible in the Valdosta Historic District. Additionally, pennant flags are considered attention getting devices and are prohibited within the City of Valdosta. One incidental sign (smaller signs, most

commonly advertising properties for sale/rent/lease) per parcel is permitted; please call the Planning and Zoning to find out what size is permitted for your particular parcel. Also, incidental signs may not be placed in the City's Right of Way or on utility poles or trees.

#### Hahira Historic District Study Committee Formed

The City of Hahira has formed a Study Committee to determine the boundaries of a local historic district, in an effort to protect the city's historic buildings. The Study Committee consists of Mayor Bruce Cain, City Councilman Mason Barfield, five members of the Hahira Historical Society, including Committee Chairman Tim Coombs, and ex-officio members City Manager Jonathan Sumner and City of Valdosta Historic Preservation Planner Emily Foster.

A historic preservation ordinance was adopted by the City in 1993 and the Hahira Historic Preservation Commission was es-



tablished soon after to administer this ordinance. However, the boundaries of the historic district that were proposed never received approval from City Council; therefore, no property was ever designated for protection under the ordinance.

So far, the Committee has met twice in October to discuss the requirements of the historic preservation ordinance and lay the groundwork for determining a historic district. Once a proposed district has been mapped out, the Committee will hold a public meeting to gather input and share information. Ultimately, any proposed historic district will need to be approved by at least 50% of the property owners within the district as well as approved by the Hahira City Council.
