- All new driveway work and all reconstructed driveway work within the public street right-of-way must be approved by the Engineering Department. Work done on ROW without a permit number is subject to being shut down until a Permit is obtained.
- If driveway work is associated with a Building Permit, note that this permit does not replace the Building Permit.
- Driveways being constructed in the Historical District require authorization from the Zoning Department prior to submittal to the Engineering Department.
- All road and lane closures and lane shifts on major roads must be approved 24-48 hours in advance.
- All pavement cuts must be repaired within 5 working days. Failure to comply can result in denial of future ROW Permit Requests until repairs are made.
- Once a ROW Work Permit has been approved, the applicant/contractor must contact the Engineering Department 48 hours prior to beginning any work within the public right-of-way at 229-259-3530. After the driveway has been formed, applicant/contractor must contact the Engineering Department again at least twenty-four (24) hours in advance of concrete delivery and pour for an inspection.

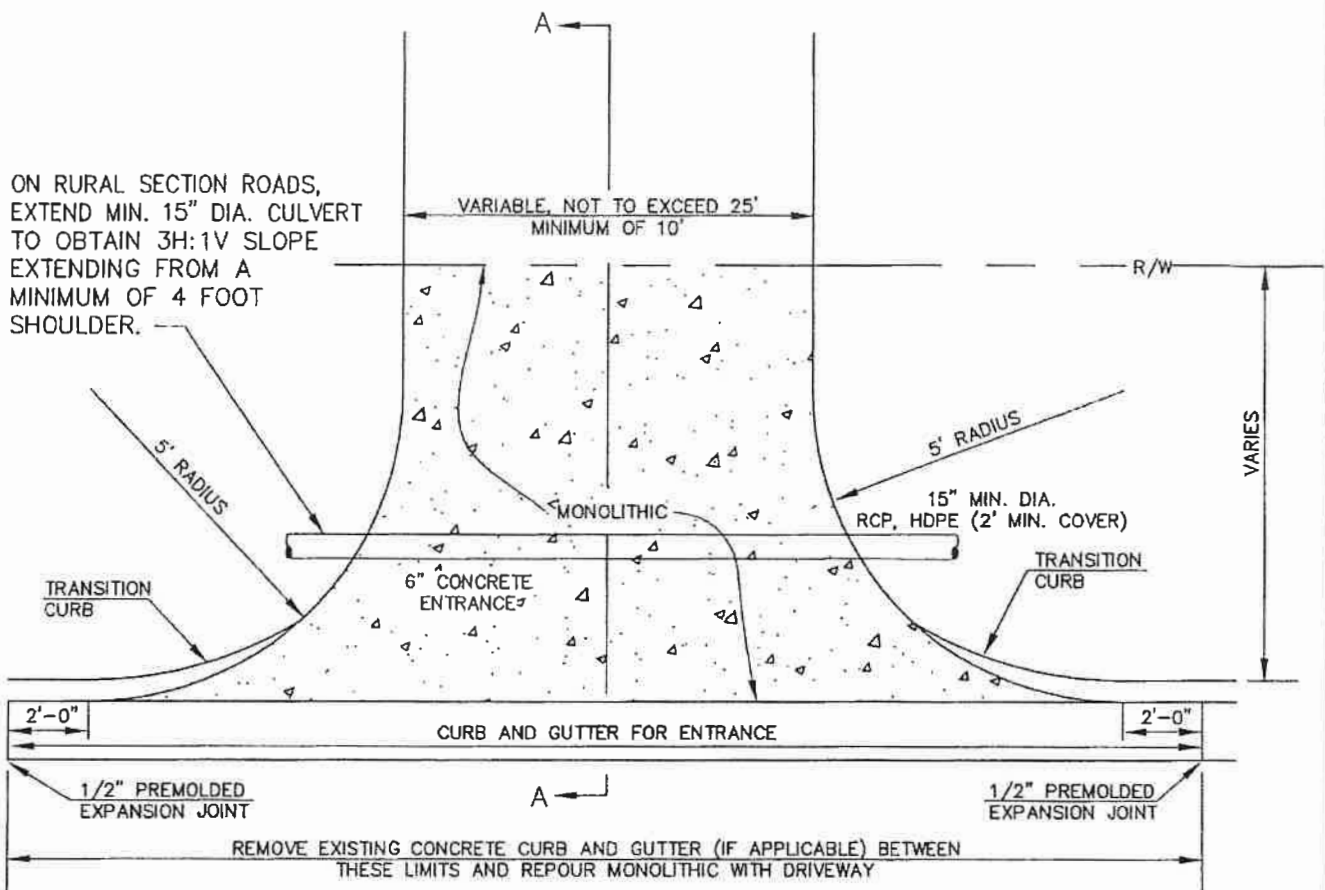

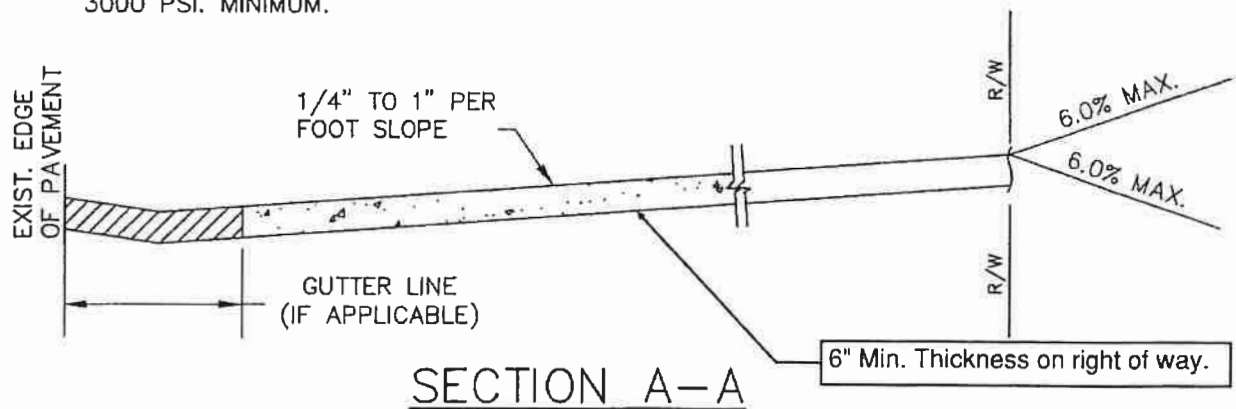
