THE IMPORTANCE OF PPE

What is personal protective equipment?

Personal protective equipment, commonly referred to as "PPE," is equipment worn to minimize exposure to hazards that cause serious workplace injuries and illnesses. These injuries and conditions may result from contact with chemical, radiological, physical, electrical, mechanical, or other workplace hazards, and with the current COVID-19 Pandemic, there is even more to consider.

Personal protective equipment may include items such as gloves, safety glasses, earplugs or muffs, hard hats, respirators, coveralls, and things of that nature. However, in the current work environment, PPE can extend to include face masks, coverings or shields, hand soap or sanitizer and

disinfectant.

All personal protective equipment should be safely designed and constructed and maintained cleanly and reliably. It should fit comfortably, encouraging worker use. If the personal protective equipment does not fit properly, it can differentiate between being safely covered or dangerously exposed. When engineering, work practice, and administrative controls are not feasible or do not provide sufficient protection, employers must provide personal protective equipment to their workers and ensure proper use.


Employers are also required to train each worker required to use personal protective equipment to know:

- · When it is necessary
- · What kind is necessary
- · How to properly put it on, adjust, wear and take it off
- · The limitations of the equipment
- · Proper care, maintenance, useful life and disposal of the equipment



- Does the \$2 fee cover a round trip, or is it just for a one-way?
- Q: A: The \$2 ride fee covers a one-way ride. Valdosta On-Demand does not offer round trips. Each ride will have to be requested separately and will be considered a separate transaction.
- Where are the vehicles located? Q:
- Ã: The vehicles are currently parked behind City Hall when they are not in use. However, drivers can pick up passengers at the nearest virtual bus stop or a specific agreed-upon location.
- Q: Does this service just operate inside the City at the ten selected locations?
- A: Currently, the vehicles only operate within City limits. The ten locations on the service map are locations in which we see high ridership. Valdosta On-Demand can take you anywhere within the City.
