#### **ORDINANCE NO. 2017-14**

# AN ORDINANCE AMENDING THE CITY OF VALDOSTA MUNICIPAL CODE OF ORDINANCES; CHAPTER 34 - COURT, SECTION 34-15 - MINIMUM COSTS; WORKING OUT

**BE IT ORDAINED** by the Mayor and Council of the City of Valdosta, Georgia, and is hereby ordained by authority of same, as follows:

That Chapter 34 - Court, Section 34-15 - Minimum Costs; Working Out of the Code of Ordinances of the City of Valdosta, Georgia is hereby amended by striking it in its entirety and substituting in lieu thereof as follows:

- 1. In case of some conviction in the Municipal Court, the cost assessable shall be as set forth in the schedule of fees and charges as noted in Exhibit A, Cash Bond Schedule for Traffic and Exhibit B, Cash Bond Schedule for Criminal, and Exhibit C, Cash Bond for Nuisance and Business, and will be kept in the office of the Municipal Court Clerk. The costs shall go into the General Fund of the City of Valdosta for general municipal purposes. Defendants unable to pay costs and compelled in lieu of payment to work on the public streets shall each be required to work sufficient time to cover costs.
  - 2. The effective date of this Ordinance will be July 1, 2017.
