What is the VSEB Program?

The government generally uses a process of purchasing goods & services from private businesses call "procurement'. The City of Valdosta uses the same process. The VSEB Program works to increase LOCAL SMALL BUSINESS participation within the City's procurement process. Here is a standard list of the types of goods and services the City of Valdosta procures:

- Construction related services (Electrical, Plumbing, Framing, etc.)
- Supplies (Building Materials, Office, Uniforms, Vehicles, etc.)
- Professional Services (Accounting, Architecture, Consulting, etc.)
- Contractual Services (Janitorial, Lawn Care, Printing, etc.)



Who May Participate

The **VSEB** Program is designed to equip local small businesses within the Valdosta Metropolitan Area (MSA) to effectively compete for City contracts.

- Owner **must be a U.S. citizen** or a lawfully admitted permanent U.S. resident
- Business owner must reside in Valdosta Metro Area (MSA) (Brooks, Echols, Lanier, or Lowndes Counties) for past 12 months minimum, OR business must be headquartered in Valdosta for the past three years minimum with owner residing in a surrounding county.
- Business owner's personal net worth must total less than \$750,000.00, excluding personal residence.
- 3-year Average Sales Revenues must not exceed certain limits for varied industry types:
 - Construction (\$3 million)
 - Contractual (\$1 million)
 - Products (\$2 million)
 - Professional Services (\$2 million)
- Applicant must own at least 51% of the business and must be an independent firm.
- Business must possess any license required by local, state, or federal law for its chosen field.
- Must be a for-profit small business (sole proprietorships, partnerships, corporations, or any other business or professional entities).

- <u>Continuing Education</u>—the Small Business Development Center, Wiregrass Georgia Technical College, Valdosta State University, and the VSEB Program offer opportunities for trade and business training (like construction management, strategic planning, customer service, accounting, and much more.)
